The enforcement actions have to do with the Economic Growth, Regulatory Relief, and Consumer Protection Act, or as I like to call it,

---

Egregious Persecution Act. Under the act, the government has the authority to investigate the amount of inventory that a company has to keep. If it is determined that the business does not keep enough inventory, it is subject to severe civil penalties for “failure to maintain adequate records,” which can include fines of up to \$1,000 a

---

day or per violation. The law also permits the government to “disgorge” any penalties collected as a result of the fines, meaning the government can take away some of the money the business owner receives in fines, as well as the money they pay in court fees and fines. Under the act, businesses that are considered

---

“small” are exempt from some of the penalties, and “large” businesses can benefit from the exemption in a variety of circumstances. But there are a variety of circumstances in which businesses are considered “large.” The Supreme Court, in a 2007 decision, determined that businesses with more than \$1.5



---

million in gross revenue in the preceding calendar year are “large.” In the Justice Department’s enforcement action against Ardenatural, the company had \$58,000 in gross revenue in 2011. Ardenatural filed a petition for review, and a group of trade associations asked the Supreme Court to hear the case. The groups

---

contended that the language of the act made it clear that businesses with revenue under \$1.5 million in a given year were exempt from the act's provisions. The companies in the groups argued that the use of "calendar year" in the act was a mistake. The act should have defined "gross revenue" as revenue for the previous calendar

---

quarter. The government responded that it is proper to use the “calendar year 2d92ce491b
